Similarly, members of the National Assembly who participated in the inauguration exercise have assured that the Assembly would continue to provide necessary support to TETFund through the enactment of legislations that would further advance tertiary education in Nigeria.

PRESIDENT TINUBU APPROVES N683 BILLION AS 2024 INTERVENTION FUNDS



President Bola Ahmed Tinubu has approved over N683 billion as 2024 allocation to Beneficiary Institutions of the Tertiary Education Trust Fund (TETFund).

This was disclosed by the Executive Secretary of TETFund, Arc. Sonny S.T Echono during the 2024 Strategic Planning Meeting held with Heads of Institutions in January 2024 at the Fund's Headquarters in Abuja.

Speaking at the meeting, Arc. Echono said "I am pleased to inform you that Mr. President has approved the Year 2024 disbursement guidelines in the total sum of N683,429,268,402.64. From this total, budgeted 90.75% direct is for and 8.94% for disbursement some designated special projects. A stabilization of 2.27% is allowed to enable the Fund respond to emerging issues. This is inclusive of the difference between actual collections and the projections made for November and December 2023 collections as requested and approved by Mr. President".

"Based on this approval, each University will get, for the Year 2024 intervention cycle, the total amount of N1,906,944,930.00. This comprises N1,656,944,930.00 as Annual Direct Disbursement and N250million as Intervention. Zonal Similarly, Polytechnic will get N1,165,355,235.00 comprising of N1,015,355,235.00 as Annual Direct Disbursement and N150million as Zonal Intervention, while each College of will N1,398,426,282.00 Education get comprising of N1,248,426,282.00 as Annual Direct Disbursement and N150million as Zonal Intervention," he added.




The Executive Secretary also disclosed approvals for new intervention lines in the Annual Direct Disbursement, which include establishment of Career Centres/Unit in all categories of Beneficiary Institutions as well as Institution-Based Skills Development for Polytechnics.

For the Special Direct Disbursement, he announced that TETFund has increased the allocation for the Special High Impact Programme (SHIP), and the number of benefitting institutions have also been increased to two Universities, two Polytechnics and two Colleges of Education per geo-political zone, giving a total of 36 beneficiary institutions in the 6 geo-political zones of Nigeria.

He further stated that other areas of Special Direct Disbursement include provision of hostels using the Public/Private Partnership arrangement, innovation hubs, disaster recovery to flood prone areas, security infrastructure, completion of abandoned projects and many others.

The Executive Secretary who spoke on the significant boost in Education Tax Collection (EDT) for 2024 said "It is pertinent to note that this represents a very significant increase above our last year's intervention and indeed every other year, since inception. 

EXCITEMENT AS PRESIDENT TINUBU INAUGURATES TETFUND PROJECTS ACROSS NIGERIA

The commissioning of projects funded by the Tertiary **Education Trust Fund (TETFund) in public tertiary educational** institutions in the country continued in the last quarter of 2023 with the inauguration of several iconic structures by President **Bola Ahmed Tinubu, GCFR.**

The President who was represented by members of his cabinet and other top government functionaries at the epoch-making events in different Beneficiary Institutions across the country expressed delight at the various projects which he said would further enhance teaching and learning and improve academic standards in the institutions.

While commending the efforts of TETFund in effectively discharging its mandate, President Tinubu assured that his administration would continue to provide necessary support towards making Nigerian educational institutions globally competitive for economic and technological development of the country.

Similarly, the National Assembly under the leadership of the Senate President, Senator Godswill Akpabio and Speaker of the House of Representatives, Rt. Hon. Tajudeen Abbas has stated that it would continue to provide necessary support to TETFund through the enactment of legislations that would further advance tertiary education in Nigeria.

The position of the 10th Assembly was made known by some federal lawmakers who also participated in the inauguration exercise.

The lawmakers expressed excitement that since the enactment of the TETFund Act in 2011, the Fund has performed exceptionally in the provision of physical infrastructure, support for academic staff training and development, book publication, ICT, Research Development amongst others in public tertiary educational institutions across the country.

At the Ebonyi State University, Abakaliki, where President Tinubu was represented by the Minister of Works, Senator David Umahi, it was an atmosphere of great excitement for the university community and other stakeholders in the state as three projects worth over N1.5 billion were inaugurated. The three projects are the ICT Complex, Faculty of Education **Building and Library Complex.**

Speaking at the event, Governor Francis Nwifuru of Ebonyi State who came alongside Senator Umahi commended the Federal Government and TETFund for the provision of the projects in the University.

He applauded the Fund's commitment towards diligence in project execution, saying that it was the right way to go in showing effectiveness and efficiency in the use of taxpayers' money.

Also speaking at the ceremony, the Executive Secretary of TETFund, Arc. Sonny Echono, who was represented by his Special Adviser on Technical Matters, Mallam Buhari Mikailu applauded the management of the university for its developmental efforts.



The Minister of Power, Chief Adebayo Adelabu was at the University of Ibadan and The Polytechnic Ibadan where he commissioned projects worth over N650 million and N1billion respectively.

The projects are the Department of Architecture building, Faculty of Technology Building at the University of Ibadan, and Faculty of Business and **Communication Studies Building, Faculty of Financial** Management Studies Building and Faculty of Science **Building at The Polytechnic, Ibadan.**



In Gombe State, 11 projects valued at over N4.5 billion were commissioned by the Minister of Transportation, Alhaji Sa'idu Alkali at Gombe State University.

The projects included the Faculty of Education **Building; Faculty of Arts Building; Faculty of Social and** Management Sciences Building and Faculty of Law **Building.**

Others are 250 capacity Drama Theatre; University Clinic; Female Hostels III and IV and a Fire Station among others.

Speaking at the event, Governor Muhammadu Inuwa Yahaya of Gombe State commended the good works being carried out by TETFund and expressed his commitment to partner with the Fund for infrastructural development of the university.


Speaking at the event, the Executive Secretary of TETFund, Arc. Sonny Echono stated that since the creation of the university in 2004, and its enlistment as one of the Fund's beneficiary institutions in 2006, over 15 billion Naira has been invested in the institution at various times for various projects.



The Kwara State University, Malete (KWASU) played host to the Executive Secretary of TETFund, Arc. Sonny Echono who commissioned three projects namely the Senate Building, the College of Engineering Workshop Extension and the Centre for Sustainable Energy Building.

Arc. Echono revealed that TETFund's interventions to KWASU commenced in 2010 and a total sum of N12,681,599,496.67 has been allocated for infrastructure-related interventions, cutting across the Annual, Special and Zonal interventions in the university.

Projects worth N873.6 million were commissioned in both Abubakar Tafawa Balewa University (ATBU) and Abubakar Tatari Ali Polytechnic (ATAP) in Bauchi State.



A total of seven projects were commissioned in the two institutions in November, 2023; four of which are in the Gubi Campus of ATBU and three at the Abubakar Tatari Ali Polytechnic.

Speaking at the commissioning, the Minister of Foreign Affairs, Ambassador Yusuf Maitama Tuggar stated that the intervention projects were part of conscious efforts by the present administration to address students' challenges and create industrial harmony between staff unions and government.

Also in Bauchi State, a library project was inaugurated at Bauchi State University by Hon. Aliyu Bappa Misau, Member, House Committee on Tertiary Education and Services.

Speaking at the event, the Executive Secretary of TETFund, Arc. Sonny Echono who was represented by the Director, Monitoring and Evaluation of the Fund, Arc. Olajide Babatunde stated that from 2012 to date, TETFund had allocated the sum of N17,336,446,369.32 for infrastructure-related interventions only.



The Senator representing Osun East Senatorial District, Senator Francis Fadahunsi was at Osun State College of Technology, Esa-Oke, Osun State for the commissioning of a 600-seater capacity auditorium and block of offices valued at N361,232,123.88.

The Executive Secretary of TETFund, Arc. Sonny Echono was represented by Mr. Okunlola Kolapo, Director, Human Resource and General Administration who implored the management of the institution to take advantage of the facilities and make adequate use of them for the educational and vocational development of the students.



From Ogun State, an array of projects worth over N2 billion was inaugurated at the Federal University of Agriculture Abeokuta (FUNAAB), Tai Solarin College of Education (TASCE), and the Federal College of Education (FCE), Abeokuta.

The commissioning was carried out by the Chairman, Senate Committee on Appropriations, Senator Olamilekan Adeola who was represented by a former Commissioner for Agriculture in Ogun state, Prof. Tope Popoola.

The projects executed at FUNAAB was valued at N1.1 billion, while those at TASCE and FCE Abeokuta cost N1 billion and N484 million respectively.

The Federal Polytechnic, Oko was also not left out of the commissioning exercises in the last quarter of 2023 as the Chairman, Senate Committee on Petroleum (Down Stream), Senator Ifeanyi Ubah inaugurated two TETFund-sponsored projects, the Male and Female Hostels worth N550 million.

Also from the South East Zone, six projects worth over N2.8 billion were commissioned at the Nnamdi Azikiwe University, Awka by the Deputy speaker, Federal House of Representatives, Rt. Hon. Benjamin Kalu, who was represented by Hon. Princess Chinwe Nnabuife, a member of the House of Representatives.

With the continuous unveiling of completed TETFund projects by the Federal Government, more facilities are being made available for use by lecturers, researchers, administrative staff and the teeming students of public tertiary institutions in Nigeria.



In a bid to leverage on the global Artificial Intelligence (AI) technology trend, the Federal Government of Nigeria received a delegation of Anthology, a leading technology company that offers Blackboard Learning Management System (LMS) to boost delivery of instructional and educational process in Nigeria. This was revealed by the President of Anthology, Joe Balenardo during a courtesy call to the Honourable Minister of Education, Prof. Tahir Mamman (SAN).

The President stated that the team is committed to making education better in the country while adding innovation and tools that will strengthen processes, data and engagements in the sector. Balenardo equally added the partnership with the Federal Government of Nigeria will enhance innovation and provide global access to learning and research materials via the learning management system.

He explained that "The Blackboard LMS currently houses about 6,000 clients and over 150 million students across the globe and is designed to create additional solutions and innovations, access to networks and give business development opportunities for learners. Many institutions around the world started a transformation to accelerate their digital journey for the great benefit of their learners. "

The Minister of Education, Prof. Tahir Mamman, while receiving the delegation in his office said the partnership is a wonderful opportunity to shape education and with the support of the TETFund, Blackboard technology will make much difference in curriculum and behavioural delivery in tertiary institutions.

According to Mamman "The Blackboard platform would ensure easy access to online academic resources and address the limitation of the physical capacity of learning and the inability to access credible learning materials. I pledge to support relevant policies that would facilitate the progress of the Blackboard project in the country.

I am a firm believer of technology; I believe in the efficacy of what we can use technology to achieve. We are at the beginning of a major reform in the education sector, from the basic to tertiary levels. We know that physical capacity is a limiting factor, but through IT, you can reach practically everybody, and we are determined to do it".

Speaking earlier, the Executive of TETFund, Arc. Sonny Echono who led the delegation to the Federal Ministry of Education stated that the Blackboard platform will ensure events such as COVID-19 whose impact won't be forgotten any time soon will no longer catch the country unaware and cripple learning activities in the country. He expressed that the learning management system would accommodate around 2.2 million users in Nigeria across the 253 beneficiary institutions of the Fund. He as well disclosed plans to enrol private institutions on the platform to further expand the number of users to over 3 million.



Reacting to concerns on the AI features of the platform and its potential threat to learning integrity and human creativity, the TETFund boss registered that AI is a fast global trend, and on area of technology, Nigeria is currently a decade behind countries like Saudi Arabia. Thus, it is crucial to focus on policy regulation on the use of AI, promote academic integrity, advocate for limitations of its usage in certain tasks and employ anti-plagiarism checkers that can identify contents that are not original.

TETFAIR: Dandutse Commends TETFund for National Development Strides

The Chairman of the Senate Committee on Tertiary Institutions and TETFund, Senator Muntari Dandutse has commended the Tertiary Education Trust Fund (TETFund) for its efforts towards the economic and technological development of the country, through giant strides in research and innovation in public tertiary educational institutions in Nigeria.

Senator Dandutse spoke at the TETFund Alliance for Innovative Research (TETFAIR) Showcase and Closing Event held in December at Innov8 Hub, Abuja.

Speaking on the TETFAIR initiative, the Senate Committee Chairman who also was the Chairman of the event stated that the programme has helped in facilitating greater partnership between researchers and the industry.

"Through the TETFAIR initiative, the nation has witnessed collaborative efforts between academia, industry, and government agencies, leading to the development of groundbreaking technologies, new medical advancements, and innovative social solutions which has positioned Nigeria as a force to reckon with in the global research community," he said.

Furthermore, Senator Dandutse stated that TETFAIR has significantly contributed in the areas of renewable energy, agriculture, and healthcare, telecommunications and other crucial sectors which have led to the development of national development goals and improvement of the quality of life of citizens and have also successfully fostered the exchange of knowledge and expertise between Nigerian researchers and their international counterparts.

He applauded the researchers and the stakeholders who contributed to the success story of TETFAIR through dedication and commitment to pushing the boundaries of knowledge and innovation in tertiary institutions. He urged them to reflect on the process and identify areas for further support and improvement.



Senator Dandutse assured that his committee would support initiatives that are capable of promoting the nation's education and economic development. He also stated that the government will continue to invest in research and development, create an enabling environment for innovation and encourage collaboration among researchers, industries and government agencies.

In his remarks, the Minister of State for Education, Dr. Yusuf Sununu described the event as timely for Nigeria which is in dire need of technological innovations to solve challenges bedeviling the country. He said this shows that Nigerians have the capacity and knowledge if given the opportunity.

He commended the management of the Fund for its relentless efforts in making sure that the public tertiary institution were gaining grounds through technological research development and innovations. He also called on TETFund to work towards stepping up protection of copyright ownership of the innovators.

Dr. Sununu stated that the Ministry of Education will continue to ensure that educational institutions translate research findings into tangible innovations useful for economic prosperity and called for greater collaboration between the academia, industry and other stakeholders to ensure the marketability of the products.





Graduate Employability: TETFund to Implement IFC Recommendation

The Tertiary Education Trust Fund (TETFund) is set to implement recommendations from the Graduate Employability Benchmark programme conducted in partnership with the International Finance Corporation (IFC) to reduce unemployment rate in Nigeria.

The Executive Secretary of TETFund, Arc. Sonny Echono disclosed this in Abuja recently during a two-day Implementation Support Workshop for the programme.

Speaking on the report of the IFC on Nigerian institutions, Arc. Echono stated that the outcome indicated that the aggregate average score of Nigerian benchmark institutions across the five dimensions of employability viz: relevance of learning, governance and strategy, employer engagement, career services/guidance, and alumni management stood at 2.3 out of 4.0, a little above 2.2 which represents the average of institutions benchmarked globally.

The Executive Secretary further stated that the institutions' digital learning strategy as shown from the report also indicated that they did not meet up with global best practices in the application of digital learning strategies; and the development required deliberate action from all stakeholders to address peculiar challenges facing Nigerian tertiary institutions to enhance the employability of Nigerian graduates.

While stating that TETFund was deliberately refocusing its intervention activities to support learning outcomes and employability of Nigerian graduates, Arc. Echono announced the approval of the Federal Ministry of Education for a Strategic and Operational Plan to refocus TETFund entrepreneurship intervention for employability and innovation.

Speaking on the IFC recommendations, Arc. Echono said "The Fund will be organizing a capacity-building programme for career unit staff in the universities designed to empower the staff and equip them with the necessary skills and knowledge to support students towards gaining the skill set to find and sustain meaningful employment.

"IFC recommendations will enhance employment opportunities, and performance, and increase career options for young graduates," he added.

He affirmed TETFund's commitment to implementing the recommendation from the employability benchmark exercise as it will ultimately improve graduate employability and reduce the high unemployment rate in Nigeria.

Speaking at the event, the Senior Operation Officer of IFC, Mr. Dina Nicholas stated that research conducted in Africa revealed that graduate employability in Nigeria was 12.1% compared to South Africa with over 24%.

He, therefore, advised universities to keep track of their graduates, promote alumnus bodies to foster development and networking, and also deploy additional efforts towards academia and industry partnership.





Nigeria, UK Intensify Educational Partnerships

As part of efforts towards further strengthening educational partnerships between Nigeria and the United Kingdom, a British delegation comprising heads of universities has paid a courtesy visit to TETFund.

The delegation which was led by the UK Government International Education Champion, Sir Steve Smith was at the TETFund office to discuss areas of mutual cooperation and partnerships between the UK Government and Nigerian varsities.

Speaking at the meeting, Sir Smith stated that there are policy schedules between the UK and Nigerian universities where there would be series of speed dating sessions and discussions on areas of mutual interest.

He added that the target was to meet about 40 institutions for partnership on key areas of regulation to foster uninterrupted collaboration, emphasizing that the UK intends to work closely with TETFund for mutual benefit.

In his remarks, the Executive Secretary of TETFund, Arc. Sonny Echono disclosed that partnerships have always been at the center of the relationship between the delegation and the Fund.

Arc. Echono noted that improving facilities in Universities, Polytechnics, and Colleges of Education in Nigeria would attract international faculties and students, while adding that the collaboration with UK institutions will focus on skill development for Nigerian institutions.

While stating that the Fund has sponsored several scholars to UK universities, he lamented the failure of some of the scholars to return to Nigeria to serve their bond.

"It is through a partnership like this that scholars who refuse to come home will be made to come back to render their services; because it is discouraging to see many of them stay abroad after they have concluded their studies. With this partnership, we can bring them back home," he said.

Arc. Sonny Echono added that collaborations with UK institutions is crucial to navigating the challenges facing Nigerian institutions, and will also help in promoting skill acquisition, research, and innovation especially as the Fund has commenced efforts towards the establishment of Multipurpose Laboratories in some selected tertiary institutions across geo-political zones.

This, he said would enable Nigeria to explore many areas of research and halt the previous culture of transporting research samples for testing and assessment abroad.

TETFund Plans for Multipurpose Laboratories, As Committee Presents Report

The Tertiary Education Trust Fund (TETFund) has thrown its weight behind the establishment of Multipurpose Laboratories with a view to sustaining the tempo of deepening research and development in the country.

This is coming on the heels of presentation of report by the Committee on Establishment of Multipurpose Laboratory led by its chairman and former Vice-Chancellor of University of Ibadan, Professor Olufemi Bamiro, to the Minister of Education; Prof. Tahir Mamman and the Management of TETFund.

Recall that the committee was inaugurated on 25th September 2023 by the Executive Secretary of TETFund, Arc. Sonny Echono who stated that it was important to work conscientiously to develop human capital and provide infrastructure to support research and development.

According to the Chairman of the Committee, Prof. Olufemi Bamiro, the team worked committedly for six weeks to ensure models and frameworks were designed in order to ensure that the laboratories function effectively for problem solving.

He revealed that during the committee's planning session, so many factors and criteria were considered for the siting of the facility such as proximity to other tertiary institutions and industries. He hinted that all Universities in Nigeria were assessed, however, members of the committee noted that the history of institutions, infrastructure, availability of land, and other facilities needed for the smooth



operation of the laboratories should play critical role in the decision-making process of the committee.

The Chairman disclosed that over 200 institutions belonging to both Federal and State Government across all regions in the country were evaluated and ranked. University of Ibadan, Oyo State and Bayero University Kano ranked highest in their respective regions, being among the first generation of universities in the country.

The presentation also revealed that the team has designed framework that would make it possible for the facility to thrive, such as autonomy, an organogram for smooth administration, governance, funding, maintenance as well as training because of the sophisticated nature of required equipment.

The committee equally emphasized that deep collaboration and partnership with development partners internally and externally such as government, internally generated revenue capacity, research grants, International Corporation, private sectors, Sustainable Development Goals, and funding are crucial to the success of the laboratories.



Responding, the Executive Secretary of TETFund, **Echono** Arc. Sonny commended the committee for their commitment to the assignment on behalf of the Minster of Education, Prof. Tahir Mamman. He equally announced that the Fund may consider increasing number of the proposed multipurpose laboratories from two to four. order in have to more representation and spread in the country.

further that He stressed the management of TETFund appreciates the committee for going beyond the terms of reference, by creating detailed proposals governance on and administrative structure, as well as considering issues around sustainability.

Echono reiterated the Fund's commitment to actualizing the project at the shortest time possible in order to speedily transform the research and development landscape in the country.

TETFUND PLEDGES SUPPORT FOR PERSONS WITH DISABILITIES By Maria Joseph

The Tertiary Education Trust Fund (TETFund) has pledged support for persons living with disabilities to ensure better access to education.

The Executive Secretary of the Fund, Arc. Sonny Echono made the pledge when the leadership of the National Commission for Persons with Disabilities paid a courtesy call on him at the Fund's office in Abuja.

Arc. Echono expressed TETFund's commitment towards supporting the activities of the Commission and pledged that the Fund would also ensure that its Beneficiary Institutions develop plans to build infrastructure that would accommodate persons with disabilities in their institutions, in compliance with subsisting regulations.

"For Nigeria to achieve inclusive education and harness all the potentials and resources in the country, there is a need for total compliance to the Discrimination Against Persons with Disabilities (Prohibition) Act, 2018 that prohibited discrimination against Persons with Disabilities.

"We will ensure that the institutions have plans to build infrastructure that will accommodate persons with disabilities," he said.

The Executive Secretary revealed that the Fund has already factored persons living with disabilities into its intervention schemes as Beneficiary Institutions have been notified to incorporate them as a priority in their programmes.

He stated that although the Fund has commenced review on sponsorship of foreign training, the Fund would be willing to make an exception where persons with disabilities are concerned.

Earlier in his remarks, the Executive Secretary of the National Commission for Persons with Disabilities, Mr. James David Lalu expressed appreciation to TETFund for its consideration for persons living with disabilities in the discharge of its mandate.

While expressing the great desire to gain higher education in the disability community, Mr. Lalu noted that most persons with disabilities have had to change their course of study due to lack of accessible infrastructure that allows for inclusiveness in our learning institutions, as most of them do not have access slopes for persons on wheelchairs and or walkways for the visually impaired.



He said the Commission has developed an accessibility standard document that would aid compliance with building codes across higher Institutions in Nigeria, adding that the document has necessary specifications and dimensions to make public infrastructure inclusive for persons with disabilities.

Mr. Lalu requested for support for the provision of Assistive Devices and Technology to enable them carry out daily activities and participate actively in learning. He noted the device has a storage capacity of up to 350 copies of electronic books.

He also solicited for scholarships and adequate training for lecturers of persons with disabilities. Specifically, he pleaded with the Fund to collaborate with foreign institutions that offer special courses in Disability Inclusion Education, where they could be trained.



He described such arrangement as detrimental to capacity building which is meant to be of benefit to universities in their administration and coordination.

"We believe in your leadership to reposition and redefine these arrangements. Our members are sidelined; we don't get access to training, conferences, and academic development. We are advocating for a semblance of democracy where scales can be balanced on training," the President said.

Sonny Echono assured that the matter will be collectively addressed, and the Fund will lead the charge for better and improved benefits to all arms of tertiary institutions as all stakeholders are vital to the Fund towards achieving the mandate of TETFund.

The Management of Kano State Health Trust Fund (KHETFUND) have met with the leadership of the Tertiary Education Trust Fund (TETFund), to study the TETFund model which has been adjudged by various stakeholders as the key to the revitalization of public tertiary educational institutions in Nigeria.

Speaking in the same vein, the Executive Secretary of KHETFUND stated that she and her management were open to learning and improving the activities of the agency in order to enhance service delivery to stakeholders and beneficiaries.

According to her, "Our visit is to find out the process in which TETFund delivers its mandate to its beneficiaries, whether it is digital or manual. While we understand that TETFund handles education and KHETFUND handles health, we share a lot of similarities in our delivery process and target audience".

According to Dr. Fatima, the major pool of KHETFUND's funding is the five percent (5%) derived from the Kano State internally generated revenue.

In his remarks, the Executive Secretary of TETFund, Arc. Sonny Echono commended the administration of Governor Abba Yusuf for continuing the good policies of his predecessor while noting that continuity of positive policies is needed for the national prosperity of the country.

Speaking on the mandates of the two agencies, Arc. Echono stated that "TETFund handles issues around infrastructure, research, book development, ICT, academic staff training and development. There are differences in services delivered - we handle education and KHETFUND handles health; however, some of our models and structure can aid the structuring of KHETFUND."
